Notes on installation

3.1 Introduction

The installation notes include important information that you need to install the SIMATIC Logon V1.6 software. Please read these notes prior to installation.

SIMATIC Logon V1.6 consists of the following components:

- SIMATIC Logon Service: provides access protection for SIMATIC applications
- SIMATIC Logon Role Management: manages the users of SIMATIC applications
- SIMATIC Electronic Signature: activates and logs actions with digital signatures for SIMATIC applications

3.2 Scope of delivery

You have received the following product with this delivery:

- SIMATIC Logon V1.6
- Order number: 6ES7658-7BX61-0YA0
- The contents of this package include the following:
 - The software package SIMATIC Logon V1.6 with one trial license
 - One USB stick with one single license for SIMATIC Logon V1.6
 - 1 software product certificate

3.3 Hardware requirements

The installation is subject to the conditions of SIMATIC PCS 7 V9.0.

To work with SIMATIC Logon V1.6, you require a programming device or a PC equipped with the following:

- Processor with at least 800 MHz
- Minimum 512 MB RAM main memory

3.4 Software requirements

Smart card reader

If you wish to work with a smart card reader, the device has to fulfill the following requirements:

- PC/SC v1.0 specification
- ISO 7816 Standard

The following smart card operating systems are supported:

- TCOS 2.0 (SLE44, SLE66, SLE66P, T-System Contactless TCOS Min, TeleSec NetKey Card Deutsche Post card)
- TCOS 1.2 (Telesec TCOS 1.2, CeloCom Card with TCOS 1.2)
- MTCOS 1.1

Note

Only TCOS 3 smart cards are currently supported when using two-factor authentication (authentication with PIN entry).

3.4 Software requirements

3.4.1 Runtime environment

SIMATIC Logon V1.6 requires the following operating systems:

- MS Windows 7 Ultimate/Enterprise/Professional SP1 64-bit
- MS Windows 8.1 Pro 64-bit
- MS Windows Server 2008 R2 Standard Edition 64-bit SP1
- MS Windows Server 2012 R2 Update Standard Edition 64-bit
- MS Windows 10 Enterprise 2015 LTSB 64-bit
- MS Windows 10 Professional 64-bit

MS Internet Explorer must be installed (at least V6.0 with ServicePack 1).

Using SIMATIC Logon in combination with PCS 7, WinCC, WinCC flexible

3.4.2 Memory requirements

SIMATIC Logon requires approximately 250 MB of space on your hard disk.

3.5 New installation

3.5.1 Installation of SIMATIC Logon V1.6

SIMATIC Logon is installed by the system setup on the CD. Select the entry "SIMATIC Logon V1.6".

You can install SIMATIC Logon over a previously installed version of SIMATIC Logon.

3.5.2 Licensing of SIMATIC Logon V1.6

Before you can work with SIMATIC Logon, you must transfer the license (usage authorization) to your computer from the USB stick with the license key. You have two options to do this:

- During the installation phase of SIMATIC Logon, the "Setup" program will display a message informing you that the appropriate license is not installed on your computer. You can then select whether you wish to have the "Setup" program install the license or whether you wish to install it later using the Automation License Manager program.
- If you cannot install the license with Setup, continue Setup without installing the license. You can install the license at a later time with the start menu command **Start > SIMATIC > License Management > Automation License Manager** or **Start > Programs > Siemens Automation > SIMATIC > License Management > Automation License Manager**.
- The license for SIMATIC Logon V1.6 must be installed on a local drive.

3.5.3 Deinstallation of SIMATIC Logon V1.6

Note

Software products must be removed according to Windows conventions.

To do this, open the Windows application "Add/Remove Software" (in the taskbar under

Start > Settings > Control Panel > Add/Remove Software) and remove "SIMATIC Logon V1.6".

This is the only safe way to remove software under Windows.

Notes on usage

4.1 General information

Note

Please read these notes carefully; they contain important information and additional details about SIMATIC Logon V1.6.

These notes take precedence over statements made in the manuals and online help.

4.2 Notes on Windows workgroups

When using a central login computer in connection with a Windows workgroup, remote queries of user, computer, and group information cannot be executed under certain circumstances. This is the case if the role management of SIMATIC Logon does not list any users and groups after you select the central login computer.

If this happens, central user administration in connection with a Windows workgroup can be supported by activating the remote query of user, computer, and group information in Windows on the login computer. You can find details at:

4.3 Notes on the online help

In rare cases, it may occur that no help topics are offered in the "Find" tab after you execute the "Find Setup Wizard".

Remedy: Copy the file "slhelp_b.fts" from the help directory (e.g. C:\WINNT\Help) to the directory in which the online help "slhelp_b.hlp" is located.

4.4 Note on smart card use

Make sure that you rewrite all smart cards that were written with a version of SIMATIC Logon prior to Version V1.3. This is necessary because SIMATIC Logon as of Version V1.3 uses an improved encryption for the smart card. You will not be able to log on with a smart card that has not been updated. However, you can always log on with your logon name and password.

If you have logged on with a smart card and remove this smart card during configuration in the SIMATIC Logon role management, all changes that you have not saved at this point are discarded. Reinserting the card will not solve this problem.

An error event may be reported in the Windows Event Viewer when a smart card is removed or inserted. This behavior is known and does not result in a malfunction with SIMATIC Logon. The same applies to permanent operation with smart card. [see also Microsoft Knowledge Base Article ID: 936156]

4.5 Notes on the SIMATIC Logon Event Log Viewer

If you want to print the events in the event log, proceed as follows:

- Click "Export" and export the events in XML or CSV format.
- Print the exported file.

In the filter dialog, the date and time are always displayed based on the settings you have made in Windows for the date and time. A display conforming to ISO 8601 is not possible.

4.6 Notes on the operating systems

You can see the a "SIMATIC Logon" link on the desktop. Clicking on the link opens the Windows Explorer with the actual links to the SIMATIC Logon programs. They can be immediately started by clicking on them.

Note

Press the right mouse button on this link and select the menu command "Pin to Start" to make this link available on the start screen. This makes it faster and easier to open the program.

In order to ensure reliable operation of SIMATIC Logon, you may neither delete nor modify those files that can be selected via the menu command **Start > Programs > Siemens Automation > SIMATIC > SIMATIC Logon > Documents and Settings** or the link **"SIMATIC Logon" > Documents and Settings** with the exception of the files in the "Diagnostics" folder, which are used for diagnostic purposes and may be deleted if necessary.

If a computer is to be used as the logon computer for SIMATIC Logon, activate file and printer sharing as an exception in the Windows Firewall (search in the taskbar for "Windows Firewall", start it and click "Allow a program or feature through Windows Firewall". Activate file and printer sharing there).

Slow response of on-screen keyboard

In Windows 8, Windows Server 2008 and Windows Server 2012, the "Microsoft OSK" and "HMI TouchInputPC" on-screen keyboards start very slowly. This delay is caused by the Internet certificate check with callback.

4.7 Configuring SIMATIC Logon

In contrast to the information provided in the "Configuring SIMATIC Logon" of the documentation, the following applies:

- The user logged on in Windows must be a member of this group:
Windows group "Logon_Administrator"
- The user to be logged on in "Configure SIMATIC Logon" must be a member of this group:
Windows group "Logon_Administrator"

This group is created automatically by the setup program on the local computer. If you also want to create and use this group on a domain, you have to add the domain group to the local Windows group "Logon_Administrator" to ensure that the mechanism works.
